### **LEI Updates**

#### Regulatory Oversight Committee meeting - June 11th-12th

The Regulatory Oversight Committee (ROC) met on June 11th and 12th. Forty six authorities from around the world participated in the ROC's second plenary meeting in Mexico City, Mexico. At this meeting, the ROC came to important conclusions, including:

- · on all material issues relating to the development of statutes that will govern the foundation at the operational centre of the global LEI system; and
- establishment of an interim "pre-LEI system" for global acceptance of "pre-LEIs" that meet global standards and following the subsequent definition of these global standards, on a process for ROC endorsement and global acceptance of pre-LEIs and pre-LOUs.

### Commodity Futures Trading Commission (CFTC) Issues Amended Order for LEI **Mutual Acceptance**

The CFTC recently (June 10) issued an Amended Order expanding, through mutual acceptance by international regulators, the list of Legal Entity Identifiers (LEIs) that can be used by registered entities and swap counterparties in complying with CFTC's swap data reporting regulations. The Amended Order revises the CFTC's order of July 23, 2012, which directed all registered entities and swap counterparties required by CFTC rules to use LEIs in swap recordkeeping and swap data reporting to use LEIs—currently known as CFTC Interim Compliant Identifiers (CICIs)—provided by DTCC-SWIFT, the utility designated by the CFTC as the provider of LEIs until establishment of the global LEI system.

#### **Update: ESMA Reporting with Legal Entity Identifiers**

While it was expected that EMIR will go live for reporting on September 23rd, this date remains uncertain and may slip towards November. ESMA reports that "on the basis of information available so far, ESMA's best estimate is that the registration of the first TR(s) is not likely to take place before August 2013 and the reporting start date depends on the actual date of registration of the first TR(s)."
